A Woman for Others

Linda Seiter of the Department of Mathematics and Computer Science wins the 2013 Curtis W. Miles Faculty Award for Service

The Curtis W. Miles Award recognizes faculty members who share their expertise with community groups and nonprofit agencies and make a significant contribution to the broader Cleveland community consistent with the University's mission and goals. The Faculty Committee on Research, Service, and Faculty Development solicit nominations from JCU faculty, staff, administrators, and students and recommends candidates with support from the Center for Service and Social Action. The award is presented during John Carroll University's Ignatian Heritage Week in recognition of the role of service in the University's mission.

Working with US Together, a local refugee resettlement organization, Linda Seiter's students taught refugees how to build an Access database, which is a marketable skill. Her students have built websites for community partners who couldn't afford to hire someone to do it. The Montefiore Senior Center, Light of Hearts Villa, the Thea Bowman Center, Fatima Family Center, Esperanza, Open Doors, and so many more have benefitted from Seiter's commitment to engaging students in service through their coursework.

GRANT SUPPORTS COURSE DEVELOPMENT IN ENTREPRENEURSHIP

John Carroll received a \$42,350 grant from the Burton D. Morgan foundation to develop units on entrepreneurship/creativity into existing arts and science courses. This approach adds another dimension of entrepreneurial thinking on the campus and complements the strong, interdisciplinary entrepreneurship minor and co-curriculars sponsored by the Muldoon Center. This year, the John Carroll entrepreneurship program was ranked 18th nationally and 1st in Ohio for best undergraduate entrepreneurship program by the Bloomberg Businessweek.


Catherine Rosemary Department of **Education and Allied Studies** (on leave Spring 2014) will develop further two studies
